If you are completing this form, you are requesting a search of our records for an existing issued grant. You are also requesting copies of the issued documents. Please note that you are able to enter a free search online at: <http://www.gov.uk/search-will-probate>

What is a General Search?

A search of the probate records for England and Wales from 1858 to the present day. General search copies are only issued with a seal if a copy is required to administer an estate within the UK. A Sealed and Certified copy would be needed to administer an estate outside of the UK.

What is a Standing Search?

If a death occurred within the last 6 months, a grant may not have been issued yet. Therefore, you may apply for a Standing Search to enable a copy to be sent to you when it issues. There is no option for sealing with a Standing Search.

If you require a copy urgently, please go in person to your local **DISTRICT** probate registry where copies can usually be provided within 10 working days. Contact your registry if the matter is of a higher urgency. Documentary evidence will be required for such urgency.
